No. 17829/2015/DP2, dated 9th October 2015 proposes to make the following individual draft variation for Conversion of Agriculture use into Public Purpose use in T.S. No. 2015/2pt, Block-42 (T.S.No. 2015/6 of Ward-2, Block-42) in Extent 17150 Sq.ft. Thimmaraya Samuthiram Village, Srirangam Division, Tiruchirappalli Corporation to the approved Railway affected area Detailed Development Plan Part—II, Tiruchirappalli Local Planning Area approved by the Commissioner of Town and Country Planning's Proceedings Roc. No. 23662/2004/DP3, dated 11th December 2008 and the fact of this approval in Form No.12 published in the *Tamil Nadu Government Gazette* No. 51, Part-VI—Section 1, Page Nos. 403 and 404, dated 31st December 2008, Publication No. VI(1)/458/2008.
