1. Supply and fixing of two Sign Boards having size of **30'x4'** ACP (aluminium casting panel) Boards (3.5 mm) having Steel letters showing "**BANIJYAKAR BHAWAN**" in Odiya and English at both sides of the North-East corner top of the building.
2. Three nos. of Halogen lights of 500 watts each shall be fitted in each board in a convenient mode for smooth repair and replacement in future for clear night views of the Display Board.
3. Installation to be made as per direction.
4. Two nos. Iron/ Steel angle frame **5'x5'** with ACP Board to be installed at both sides of main gate with Steel letters showing name of the offices as attached separately.
5. Floor chart showing location of different office chambers in each floor (**ACP base with 1.5" Hindalco Aluminium Channel**).
6. The quoted price shall include erection, transportation, installations with power supply to the Halogen lights.
