





SEALED TENDER NOTICE

Sealed tenders in plain paper are invited by the undersigned from the intending bidders for auction sale of the office vehicle (Jeep) bearing Registration No. OR-05-D-9606 on "as is where is basis". **The offset price of the vehicle has been fixed at ₹32,000.00 (Rupees thirty two thousand) only.** The intending bidders may inspect the vehicle in the office campus of the undersigned located at Sriram Nagar, Badambadi, Cuttack on any working day during office hours from 11 A.M to 4 P.M before 27.12.2013. The intending bidders may submit their sealed tenders which should accompany earnest money deposit of ₹2,500.00 (Rupees two thousand five hundred) only in shape of bank draft payable at S.B.I, Link Road Branch, Cuttack in favour of the Deputy Commissioner of Commercial Taxes, Cuttack II Circle, Cuttack. The earnest money of the unsuccessful bidders shall be returned to them immediately after the acceptance of the highest offer. **The last date for receipt of sealed tenders is fixed on 27.12.2013 by 5 P.M.** and the tenders so received shall be opened on 28.12.2013 (at 11.30 A.M) in presence of the bidder if any. The highest bidder whose tender will be accepted shall have to deposit 25% of the tendered amount by 30.12.2013 and the balance by 02.01.2014. In case the bidder fails to make the deposit in full as per the terms of the notice within the stipulated time the deposit already made along with the EMD shall be forfeited. The amount deposited in shape of EMD and at the time of acceptance of the tender shall be subject to adjustment at the time of final payment. The bidder shall have to remove the vehicle from the office campus of the undersigned within seven days from the date of deposit of the full amount quoted. On failure to remove the vehicle within the stipulated time shall attract payment of ground rent @ 1% of tender amount per day till removal of the vehicle from the campus. If the ground rent so charged shall exceed the sale price deposited the bidder shall cease to have any right over the vehicle and the amount deposited shall be adjusted towards ground rent. The undersigned reserves the right to accept or reject any or all tenders without assigning any reason thereof.
